# <u>What's Behind Numbers? A Guide to Determine Risk Exposure and Avoid Huge Losses in Your Portfolio\*</u> by Ricky Park

Explore how the equity risk premium model can explain the breakdown of risk exposure and investment characteristics with portfolio and fund in looking forward basis. Market uncertainty has been creating increased volatility of asset price. While diversifying risk is of high interest to asset managers, the risk exposure explains the outperformance of investment methods as well. In other words, risk should be managed effectively while risk can be used to determine investment strategy with a given market outlook. This class introduces the role of equity risk forecast model in portfolio analytics and tools to conduct scenario testing and stress testing with portfolios and funds to avoid huge losses.
