



## 2027 / 2028 臺灣大學管理學院與京都大學經營管理大學院雙聯學位(碩士+碩士) 計畫甄選簡章

### 2027 / 2028 NTU CoM and Kyoto GSM Double Degree Program (Master) Call for Application

#### 一、宗旨 Purpose

甄選學業優良、外語流利、品性良好之本院學生，於每年四月赴日本京都大學經營管理大學院研修一學年，藉此培育學生國際觀，並促進國際學術交流。學生得於符合兩校規定下，獲頒本院與京都大學經營管理大學院所授予之正式學位。

We would like to select students who have excellent academic performance, are fluent in foreign languages, and have good character to join the double degree program. Selected students will go abroad to Kyoto Graduate School of Management (Kyoto GSM) of Japan in April for one academic year and obtain an international perspective and promote international academic exchanges. Selected students shall comply with the provisions of the two schools and will receive formal degrees awarded by the College of Management of National Taiwan University (NTU CoM) and Kyoto GSM upon the completion of all requirements.

#### 二、申請資訊 Application

**錄取名額**：本院碩士班學生 2 名 (得從缺)

**Number of Admissions**: Up to 2 Master students (quota may be left unfilled)

#### 申請資格 Eligibility

1. 本院會計研究所、企業管理碩士專班(GMBA)二年級 (含) 以上之在學碩士班學生。(不含休學中學生)

Applicants are required to be at least second-year Master-level candidates in the graduate institute of Accounting or GMBA. (Students must be enrolled at the time of applying).

2. 學業成績優良，平均成績達 GPA 4.0 (含) 以上。

Excellent academic performance and the average GPA is more than 4.0.

3. 語言能力規定 Language Abilities

- (1) 如欲申請京都大學經營管理大學院英語授課課程—國際 MBA 課程 International MBA Program

(i-MBA)，需具備托福(TOEFL-iBT) 90 分 (含) 以上或雅思(IELTS) 7.0 分 (含) 以上(必須)。另如有 GMAT 550 分或 GRE 310 分 (含) 以上之成績，建議提供(非必須)。

\*\*學士或碩士學位於英語系國家(包含美國、英國、愛爾蘭、澳大利亞、紐西蘭及加拿大<魁北克地區除外>)取得者，得免附英語能力證明。

\*\*學士或碩士學位於英語系國家(包含美國、英國、愛爾蘭、澳大利亞、紐西蘭及加拿大<魁北克地區除外>)取得者，得免附英語能力證明。

If an applicant would like to take the English taught program –International MBA program (i-MBA) offered by Kyoto GSM, then TOEFL-iBT 90 scores (or higher) or IELTS 7.0 (or higher) is **required**. A GMAT



score of 550 or above 、GRE310 or above is recommended but not required.

\*\*(Students with undergraduate and/or graduate degrees obtained from an English-speaking country (including the United States, The United Kingdom, Ireland, Australia, New Zealand, or Canada<except Quebec>) are exempted from this requirement.

- (2) 如欲申請修習京都大學經營管理大學院日語授課課程——財務會計、商業領導、服務管理或專案營運管理，須具備日本語言檢定 N1 級。

If an applicant would like to take the Japanese taught program –Business Leadership, Project Operations Management, Service, Tourism and Art, Finance and Accounting, then JLPT Level N1 is required.

4. 赴京都大學經營管理大學院之前，會計研究所學生應完成系所要求之所有先修課程及必修課程；企業管理碩士專班（GMBA）學生應完成所有必修課程。

An applicant who belongs to the graduate institute of Accounting shall complete all the prerequisite courses and the required courses at NTU COM before enrolling at Kyoto GSM. Any student who belongs to the GMBA shall complete all of the Core Courses at NTU COM before enrolling at Kyoto GSM.

### **學分規定 Credit requirements**

1. 京都大學的畢業學分為 42 學分。

Credits Required for Graduation is 42 credits.

2. 赴京都大學經營管理大學院修業期間應至少取得 22 學分，包括：專業科目 14 學分及實務科目 8 學分；如修習常規課程，其中專業科目 8 學分及實務科目 4 學分，應分屬各學程之指定科目；如修習國際 MBA 課程，其中專業科目 10 學分及實務科目 6 學分應屬指定科目。此外，學生須另取得高等科目 4 學分，亦即研討會(Workshop) (I)、(II)。

A DDP student shall take a minimum of 22 credits at Kyoto GSM, including 14 credits from specialized subjects and 8 credits from practical subjects, of which 8 credits from specialized subjects and 4 credits from practical subjects shall be taken from the subjects designated for each program in the case of Regular Course, and 10 credits from specialized subjects and 6 credits from practical subjects shall be from designated subjects for the International MBA program Course.

In addition, students are required to take 4 credits from advanced subjects, titled Workshop (I) & (II), mandated and offered at Kyoto GSM.

3. 學生在本院修習之學分，經京大教務委員會核可，京大經管院至多可採計 20 學分。所修習之科目，如在臺大管院與京大經管院屬相同科目者，學分不予以採計。

A maximum of 20 credits can be transferred from NTU COM, subject to the approval of the Kyoto Academic Affairs Committee. It is not acceptable to obtain credits for similar subjects at both Kyoto GSM and NTU COM.

4. 學生毋須撰寫日本京都大學經營管理大學院之畢業論文，唯本院之畢業論文仍應完成。



A DDP student does not need to write a thesis with Kyoto GSM but **will have to complete the graduation thesis of NTU COM.**

## 修業期間 Studying Period

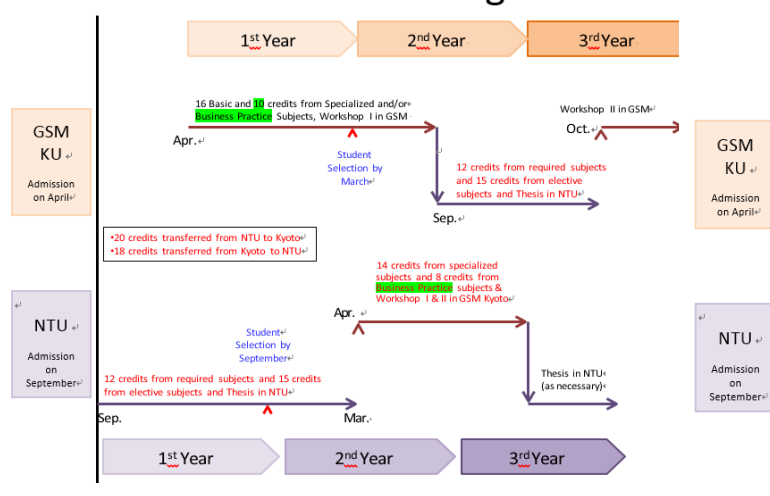
本計畫之總修業期間，原則上均為三年。參與學生在接待學校之修業期間，原則上為一年(兩學期)。

\*請注意，京都大學的兩個學期會跨越本校三個學期。

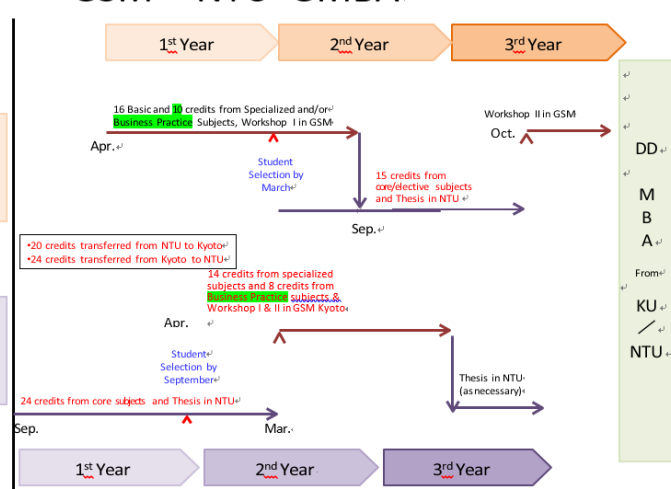
The program will, in principle, last for three years. A DDP student will, in principle, stay at the host university for one academic year.

## 申請文件 Application Portfolio

1. 申請表。(請至管院網站下載申請表格，英文繕打)

Application form. (Downloadable from the College of Management website and shall be filled out in English)

2. 讀書計畫。(請說明於京都大學的規畫、展望與研究主題，英文繕打 A4 一面，無格式限制)

Study Plan. (Please include what you would like to learn and your study topic at GSM Kyoto University. Shall be written in English and is limited to one side on size A4 paper)

3. 成績單英文版正本一份。

A university official transcript in English

4. 有效期限內語言能力證明影本一份：(僅接受近期 2 年內的成績)

Photocopy of effective language certificate (must be taken within the last two years)

- (1) 如欲申請京都大學經營管理大學院英語授課課程——國際 MBA 課程 International MBA Program (i-MBA)，需具備托福(TOEFL-iBT) 90 分 (含) 以上或雅思(IELTS) 7.0 分 (含) 以上(必須)。另如有 GMAT 550 分或 GRE 310 分 (含) 以上之成績，建議提供(非必須)。

If an applicant would like to take the English taught program – International MBA program (i-MBA) offered by Kyoto GSM, then TOEFL-iBT 90 scores or IELTS 7.0 (or higher) or is **required**. A GMAT score of 550 or above、GRE310 or above is recommended but not required.

**\*\* (Students with undergraduate and/or graduate degrees obtained from an English-speaking country (including the United States, The United Kingdom, Ireland, Australia, New Zealand, or Canada<except Quebec>) are exempted from this requirement.**

- (2) 如欲申請修習京都大學經營管理大學院日語授課課程——商業領導、專案營運管理、服務管理或財務會計，須具備日本語言檢定 **N1 級**。

(If an applicant would like to take the Japanese taught program – Business Leadership, Project Operations Management, Service, Tourism and Art, Finance and Accounting, then JLPT Level N1 is required.

5. 教授推薦信一封。(請至管院國際事務室雙聯學位計畫網站，下載制式表格，中、英文皆可)

Recommendation Letter. (Downloadable from the Dual-Degree program, College of Management website and shall be filled out in Chinese or English)

註：書面資料須依以上順序排列，以長尾夾或迴紋針固定，不得裝訂或使用釘書針。

Note: The application portfolio shall be submitted with a binder clip or paperclip in the order listed.

### 三、 報名時間/方式 Application Period & Procedure

1. 報名時間：**2026 年 8 月 24 日(一)- 27 日(四) · 上午 9:00-12:00 / 下午 2:00-4:00**。

Application period: **August 24-27, 2026, 09:00-12:00am, 2:00-4:00 PM.**

2. 報名方式：將所有申請文件繳交至管理學院一號館 9 樓 903 國際事務室。

Application Procedure: Deliver your Application Portfolio to Office of International Affairs, Room 903, 9th floor, Building I, College of Management, NTU.

註：已完成報名手續者，不得要求退件。所有書面資料將不歸還，如有需要，請申請者自存副本。

The Application Portfolio cannot be returned. Please save your own documents in an electronic file well.



#### 四、甄選方式 Selection Method

1. 書面審查：申請者之書面資料經評審委員審查後，必要時，得進行面試。

Application material review: Interviews might be conducted after the review of written materials if the committee thinks it is necessary.

2. 最後錄取結果依申請人所繳交之書面資料與面試表現綜合評定。

The result will be determined according to both the application portfolio and interview performance.

#### 五、錄取名單公告 / 錄取確認 Announcement & Enrollment Confirmation

錄取名單預定於 **2026 年 9 月 11 日(三)下午 4 時前**公告於管院網站，錄取學生須於 **2026 年 9 月 16 日(三)下午 4 時前**持錄取確認單至管院一號館 9 樓 903 國際事務室確認。未如期確認者，視同放棄錄取資格。

The admissions list is scheduled to be announced on **September 11, 2026 before 4:00PM** on the website.

Admitted students must turn in their confirmation letter to the Office of International Affairs, 9th floor, Building I, College of Management **by 4:00 PM on September 16, 2026**. Those whom do not confirm their position will be deemed disqualified.

#### 六、學生須知 Student Conditions

1. 錄取雙聯學位學生由本院甄選推薦，其入學許可之核定由接待學校決定。申請人須自行確認是否符合該校申請資格，若被該校拒絕入學或未獲核可入學，即喪失錄取資格，申請人不得有異議，且須繳交罰款新臺幣 15,000 元整至本院國際化專用帳戶。如有任何不可抗力因素，管院國際室得做其他適當處置。

Applicants are subject to the approval by the selection board and the final decision shall be made by the host university. In the event an applicant is disqualified for not meeting the criteria, no objections are allowed. Additionally, the applicant must pay a penalty of NT\$15,000 to the College's designated internationalization account. In the case of force majeure, the Office of International Affairs, College of Management, reserves the right to take alternative and appropriate action.

2. 一經放榜，不得以任何理由要求更換錄取學校（院），亦不得以任何理由延後出國研修學期或要求保留錄取資格。

Once the results are posted, under no circumstances will the accepted applicants be allowed to switch schools nor will the students be allowed to postpone the mandatory training program.

3. 除重大天災等不可抗力之因素外，錄取學生未如期赴國外研修、或因可歸責於個人之因素（如：資料不全）而未獲接待學校核可入學、或終止本計畫提前返國者，皆視為放棄錄取資格。

Other than a natural disaster, students must attend the training program. Admitted students who do not attend the training program due to reasons outside the school's approval or leaves the program on their own accord are deemed to have waived their status in the program.



4. 錄取學生於確認錄取資格後不得任意放棄雙聯學位學生資格·放棄資格者·須繳交罰款新臺幣 15,000 元整至本院國際化專用帳戶。

Accepted students who have confirmed their enrollment into the dual-degree program shall not rescind their decision. Students who choose to withdraw from the program shall defray NT\$15,000 deposit in the d the College's designated internationalization account.

5. 錄取學生須在本校註冊並繳交全額學雜費·免繳交接待學校學雜費及學分費。食宿費、旅費、書籍費、交通費、護照費、簽證費、保險費及其他個人支出須自行負擔。

Accepted students shall pay the tuition and credit fees of their home university and are exempt from the tuition and credit fees of their host university. Students are responsible for their own room and board, travel expenses, books, transportation costs, passport and visa fees, insurance, and other expenses which may occur during their stay overseas.

6. 所有錄取學生皆須自行辦理宿舍申請、簽證、選課、機票、機場接送及保險等個人事宜。

All admitted students are required to apply their own dormitory, visa, courses, flights, airport transportation, insurance, and other personal matters.

7. 除學生平安保險外·本院有權強制所有錄取學生於出國研修前另購買足額之保險 ( 含醫療、意外、海外急難救助等 )。本院不具替學生購買保險之責任與義務·若學生未購買保險·本院保有取消其錄取資格之權利。

In addition to student insurance, NTU COM requires students enrolled in the dual-degree program to purchase insurance that covers medical, accident, and overseas disaster expenses. Though the university cannot force a student to purchase the insurance, if the student chooses not to purchase the insurance, NTU COM retains the authority to disqualify the student from the program.

8. 本計畫未保證可申請到接待學校宿舍·本院不負責協助宿舍申請·接待學校亦無保證提供宿舍之義務；未申請到宿舍之學生·須自行安排外宿事宜。

The dual-degree program cannot guarantee dormitory housing from the host university and NTU COM is not responsible for assisting with dormitory applications. If a student is unable to apply for dormitory housing, they shall have to arrange other sleeping quarters.

9. 若因個人因素無法取得學生簽證者·錄取資格即取消·本院不負責協助學生辦理簽證。

NTU COM is not responsible for assisting with the students' visa application. In the event a student is unable to obtain a student visa, their enrollment in the program shall be rescinded.

10. 雙聯學位學生須依照接待學校要求完成選課、修課等·並於每學期末成績公告時·將正式成績單掃描檔或電子檔寄至承辦人電子郵件信箱。

Accepted students must complete course selection and coursework in accordance with the requirements of the host university. At the end of each semester, upon the release of grades, they must email a scanned copy or digital version of the official transcript to the coordinator's email address from College of



Management, NTU.

11. 錄取學生於計畫期間結束後，如未能完成本計畫之全數規定，將不授予雙聯學位。  
If at the end of the arranged period a student fails to meet and complete all the conditions of the program the student shall not be granted a dual degree.
12. 申請及參與本計畫期間不得辦理本校畢業或休學手續，若有此等事情發生，將取消其雙聯學位學生身分。  
If during the application period a student graduates or withdraws from school, the student's dual-degree status shall be revoked.
13. 本計畫結束後，必須按時回到本校繼續完成學位，不得擅自延長停留期限。如有違反情況，須自負一切法律責任並按校規處置。  
At the end of the scheduled program period, all students shall report back to their home school to complete their degree. No extensions shall be granted to complete the overseas portion of the program. Any violations shall be viewed as disqualifying acts.
14. 所有學生返國後，不得以任何理由要求退還學分費或學雜費。  
After a student return to their home school, no requests for a refund of tuition or credit fees.
15. 具役男身分同學須依法完成相關手續，並於計畫期結束後準時返國，不得有滯留國外之情形；如有違反情況，須自負一切法律責任並按校規處置。  
Students must act according to the laws and regulations of the program. Students are required to complete the program within the allotted time period and return to their home school. In the event a student is stranded overseas, they shall have to handle it legally.

## 七、雙聯學位學生義務 Double Degree Student Obligations

1. 雙聯學位學生於接待學校完成註冊手續後，即視同該校學生，應遵守該校一切規定，不得做出有損兩校校譽之情事，如有違反情況，須同時接受兩校校規處置。  
After a dual-degree student registers with their host university, they have deemed a student of that university. Under no circumstances shall a student do anything which may harm the reputations of the two universities they represent. Any violations shall be handled according to the rules and regulations of the two schools.
2. 出國參與計畫期間須密切與本院保持聯繫，並留意自身安全。  
Students shall maintain a line of communication with NTU COM over the course of the program and shall be aware of their own safety overseas.
3. 所有參加本計畫學生，應於返國後一個月內繳交在接待學校研修心得報告後，方可領取接待學校之成績單或相關文件。本院有權在網路公開同學所繳交之報告，或使用於各種相關活動文宣用品上，



不須另徵得其同意。

All students in the program shall submit a report regarding their studies and experiences overseas. NTU COM maintains the right to use and report any information in the reports for commercial purposes related to the College of Management.

4. 雙聯學位學生返國後，於在學期間應盡義務協助及輔導本校同學，提供相關諮詢及資訊。本院有權提供其聯絡方式給往後錄取之同學，不須另徵得其同意。

After returning to their home university, dual degree students are responsible for providing advice to their fellow classmates. The College reserves the right to share their contact information with future admitted students without obtaining additional consent.
